## DATA PROTECTION

The Board of Management of Coláiste Pobail Bheantraí is a committee of Cork ETB,<sup>21</sup> Lavitt's Quay, Cork City, T12 HYT9 which is a data controller under the General Data Protection Regulations and the Data Protection Acts 1988 - 2018. all of which are tasks carried out pursuant to various statutory duties to which Cork ETB is subject.
